- ⌘ Three phase metered power to the Outdoor unit is required by others prior to the installation of the air conditioning system.

Special Site Considerations:

- ⌘ A site visit is required at frame stage to confirm pricing, outlets or equipment.
- ⌘ Assistance with your builder is required, during the installation of the air conditioning system.
- ⌘ The weight of the fan coil unit may exceed builders requirements, please notify your builder.

The Manufacturers' 5 years Parts and Labour Warranty applies to all products installed by TOZER Air Conditioning.

Features of Ducted systems include:

- † Microprocessor controlled operation and monitoring.
- † Instant computerised self-diagnostic system, for reduced diagnostic time in the unlikely event of a breakdown.
- † Auto restart after power failure.
- † Spare parts are readily available.

TOZER Air Conditioning also provides a yearly maintenance program to keep your air conditioner in the best shape and to avoid any Warranty problems. If a component fails in your Air Conditioning system during the 5 year warranty period, the manufacturer will replace the part free of charge. However if the part fails due to lack of maintenance it may not be covered by your warranty.

Inclusions:

- † 5 years manufacturer parts and labour warranty, 5 years warranty on installation.
- † 10 years warranty on duct and fittings.
- † 5 years warranty on all zone motors.
- † Pipe covers to cover all external pipes and wiring.
- † Pre cast concrete steps, brackets or plastic feet are provided; however the laying of a concrete pad is recommended, (by others).

Exclusions:

- † Any asbestos found that needs to be cut or removed will be done by a licensed tradesman at a cost to the customer.
- † Any boxing in of duct work that may be required due to duct needing to be run externally from roof space.
- † The weight of the fan coil may exceed builder's requirements, please notify your builder prior to installation.
- † Whilst all care is taken during the installation Tozer is not responsible for popped nails due to movement in the glue when working in the ceiling.

Recommendations:

- † Outdoor unit should be positioned at least 3 metres from the boundary.
- † Discussion with our installer is advisable prior to installation.
- † The installation of ceiling insulation would increase the performance of the Air Conditioner and reduce running costs.

Title of goods:

Title to the system will remain the property of TOZER Air Conditioning until all money due to this company has been paid. This includes the right to recover installed materials, and client thereby indemnifies TOZER Air Conditioning and its staff in any way regarding any entry to premises and removal of its property and client agrees to forfeit all monies paid hereunder.

Conditions of payment:

A minimum deposit of 10% of the total cash price is due on acceptance of this quote with the balance payable on the day of installation.

For systems that are to be installed in two parts there will be a progress payment of 50% due at commencement and the final 50% to be paid on the day of completion.
