I understand that an additional fee of \$100 will be charged if the driver cannot deliver and is required to return again, or less than 24 hours cancellation notice is given. I agree to allow Planit Kitchens unrestricted access to the site to carry out installation and any rectification work as required. **I understand that any variation to this contract must be signed and approved by both parties prior to any such variation being completed.**

I understand that a fee of 18% PA will be payable on any overdue outstanding account, unless prior alternative arrangements have been made, and that should Planit Kitchens need to institute legal proceedings to recover any such overdue accounts, I will be liable for all costs involved. All cabinetwork and fittings included in this contract remain the property of Planit Kitchens until payment is received in full. I understand that I have the right to cancel the contract within 5 business days of signing the contract for jobs over \$20,000.
